#### **ELECT CHAIRPERSON:**

## **JEFFERSON CANE:**

• Leah Libby was presented with the Jefferson Cane and given a certificate as the oldest resident in town.

### **SOLAR FARM ORDINANCE:**

- Bill Farren was present.
- There will be a new permit application based on the new Solar Farm Ordinance.
- The Building Ordinance will be modified to include more detail on Residential and Commercial Solar Panels and an additional piece will be added to the current building permit application as a result. Of the subset of the current building permit application as a result.
- Lynne will contact the State to see if the CEO will need any additional training/certification for Solar Farms.
- There will be something added to the Solar Farm Ordinance that will require new owners, after a change in ownership, to review and understand their responsibilities as the new owner of a Solar Farm.
- There will be something that states the decommissioning of a Solar Farm is the sole responsibility and expense of the applicant.
- Lynne will print a copy of the Solar Farm Ordinance to give to the Code Enforcement Office for his review and understanding.
- Fees will be set at \$10,000 for a large farm and \$5,000 for a medium farm.
- There should be a requirement for an annual letter/form that states they are still in operation and how much they are generating annually.

## **ROAD COMMISSIONER:**

- Egypt Road:
  - The Road Commissioner has ditched up to the first driveway and expects to get to Siegried Lane by the middle of May. He's only replaced two culverts so far.
  - Blasting stays on the agenda until the ditching gets done.
- The Road Commissioner has dropped two loads of gravel to the Old County Road.
- Discussion of grading on Hallowell Road the grading company will be in the area and has provided a quote of \$500 The Select Board has given them the go ahead because the price is reasonable, and they will be in the area.

#### PERSONNEL POLICY:

 Pam has been reading the draft personnel policy and asked Claudia and Robert to review their copies for discussion over the next few Select Board meetings.
