FOLLOW-UP FROM 08/12/2024 SELECT BOARD MEETING:

- Salt Shed and Town Office lighting has been fixed and is working.
- Lynne will contact Dan Orff tomorrow about readside mowing.

ROAD COMMISSIONER:

- SENNETT ROAD and NORTH MOUNTAIN ROAD
 - o There are 3 trees down on the Sennett Road and 1 tree down on the island between North Mountain Road and Village Street. The trees on the Sennett Road have been marked with a ribbon and the Road Commissioner will mark the tree on N. Mountain Rd/Village St with a ribbon.
 - Lynne will contact Donnie Clark to have him remove the trees.
- EGYPT ROAD
 - o CMP was supposed to put up a support beam so the blasting could take place, but they didn't so the Road Commissioner will need to rent a hammer to break up the area.
 - We need to put out a Request for Bid needs to be advertised for Grading on the Egypt Road.
 - 2.5 miles on the Egypt Rd from Rte. 215 to the Alna town line.
 - Bids should be received by 10/04/2024.
 - The work needs to be completed by 11/01/2024.
 - Grading, grinding and rolling with a 2-inch base of hot top and 16-feet wide.
 - Call Maine-ly Paving, LLC and All State Asphalt, Inc. to let them know there the RFB is going out.
- PEGGY HODGKINS contacted the Road Commissioner because the beavers have dammed up the culvert
 at her driveway and feels the Town should take care of it. The Road Commissioner also mentioned that
 the beavers had blocked up the culvert on the Egypt Road too.
- NORTH MOUNTAIN ROAD Valerie Jones called Tom Durkee about 3 maple trees on North Mountain Road – she has stated the Town killed the middle tree and wants the Town to take it down. The Select Board will investigate it.
- HALLOWELL ROAD Robert received a call asking when we were going to do something about the road condition. There was discussion about using the LRAP funding to make the repairs.

LRAP REPORT:

- Last year we didn't use any of the funds (approx. \$53,000)
- This year we're going to use it on Egypt Road (approx. \$54,000).
- Put this back on the 09/23/2024 agenda to discuss using some of the funds for the Hallowell Road repairs.

Approved Town Expense Warrant in the amount of \$834,974.15.
