## **ROAD PAVING BUDGET:**

• Robert requested the balance of the roads budget – Lynne will call him with the information.

## JOAN JACKSON:

• Joan read a letter to the Select Board expressing her displeasure with the way the notifications were made about who was reappointed to the Budget Committee. She read it in the paper and nobody had contacted her. Joan requested a copy of her letter be attached to the minutes of the meeting. – The Select Board thanked her for all her volunteer work she does for the Town and apploprized for the missed notification.

## SOLAR ORDINANCE:

• Bill Farren, Chair of the Planning Board, was present.

- Discussion was had about the requirements for residential/commercial solar panels and getting
  the information on the Building Permit and making an amendment to the Building Ordinance.
  Discussion was had about what fees would be charged. The information is necessary for safety
  precautions.
- Pam had some questions:
  - How will the Jefferson Fire Department get notified about the layout and specifications of the layouts – Bill will talk with Darin Walker (Fire Chief) to determine how best to convey the information.
  - Why are we requiring a building permit if there are no fees per Claudia the solar panels add value to the property therefore need to be documented.
  - o Inspection of the installation and the ability of the roof to handle the panels per Bill, the Installer will make that determination.
  - O Would there be any training for the CEO to know what to check/verify proper installation and if it's working properly in order to sign off?
  - Modifications to the original plan for the solar panels/farm would there be a separate form or modify the original permit:
  - O Discussion was had about setting the fees at 15¢ per square foot.
- Discussion was also had about who is able to make changes to the building permit the Select Board, the Planning Board, and Town Residents with a properly signed petition was discussed.

#### ROAD COMMISSIONER:

- Hallowell Road Wayne asked if there is grading to be done on Hallowell Road this year.
- A motion was made to grade the Hallowell Road and to have Harry Moody do the grading seconded. (3-0)

### **TOWN APPOINTMENTS:**

- The Select Board signed the appointment papers.
- Donald Waltz isn't ready to be sworn in as CEO.

# ANDREW WILLIAMSON SCHOLARSHIPS:

• The Select Board signed the scholarships.

#### **CODE ENFORCEMENT OFFICER:**

- Tom Durkee, Donald Waltz and Tom Prouty were all present.
- Tom Prouty wants to know why the Colvin's are still sawing and there is electricity running to the shed when there's supposed to be a Cease and Desist order in place.
- Tom Durkee has been reaching out repeatedly to the DEP Agent Colin Clark about the best way to handle it without disrupting the State's investigation. Pam will call Colin directly to try and get a response.
- A motion was made to send another registered letter to the Colvin's. The letter will give them 30 days from the date the letter is served to remove the structure/building or they will begin to

receive a fine of \$250.00 per day until the structure has been removed. The letter to be served to the Colvin's by the Lincoln County Sheriff's Office. – seconded. (3-0)

ON PREMISES BEER, WINE, AND SPIRITS APPLICATION:

• New applications are coming frequently – Lynne will email each permit applicant to notify the Lincoln County Sheriff's Office and the Jefferson Fire Department of each event.

Approved the Town Expense Warrant in the amount of \$32,576.75.

• There was an error in Robert Clark's check that needed to be corrected.

The Select Board entered Executive Session at 5:50 pm for poverty tax abatement 1 M.R.S §405(6)(F). The Select Board exited the Executive Session at 5:57 pm.

• A motion was made to deny the poverty tax abatement – seconded. (3-0)

The Select Board entered Executive Session at 6:05 pm for personnel matters 1 M.R.S §405(6)(A). The Select Board exited the Executive Session at 6:30 pm and no vote was taken.
