#### **APPOINTMENTS:**

 The Select Board signed the appointment papers for Leah Nook Frost, the newest member of the Library Committee.

#### ROAD COMMISSIONER:

- Glidden Bridge on Sommerville Road
  - o The State DOT has posted the weight limit signs.
  - ODOT has suggested finding out if Sommerville is going to upgrade their bridge if they don't then Jefferson may not want to upgrade theirs either because if they do then all of the traffic will come over Jefferson's bridge.
- County Bridge on County Road/South Clary Road
  - o The bridge is peeling away, and it has considerable sagging. Further discussion to take place.
- Hodgkins Hill Road
  - o There is a large pothole that needs to be repaired.
  - Wayne drove by the pothole on his way home and called in to say there was no ditching along that section of road and the water was backing up and breaking down the pavement.
  - The Select Board gave permission to fix the problem.
- There weren't any additional road complaints.

• The Pam signed the letter of denial that was approved at the last Select Board meeting.

## **ROADSIDE MOWING:**

- Lynne is to contact Gary Castner, who had the roadside mowing contract last year, to find out if he will continue to do the roadside mowing for the same price as last year.
- A motion was made to renew the contract with Gary Castner for another year if the contract price will remain the same seconded (3-0)

### **SOLAR ORDINANCE:**

• Lynne spoke with the Assessor and provided that both the rooftop and lawn solar panels are taxed and also that the residents can apply to the state for a rebate.

# **CODE ENFORCEMENT OFFICER:**

- Lynne spoke with Tom Durkee, who said that it was Donald that should write the letter notifying Matthew and Marlene Colvin of the fines that will begin accruing if the shed is not taken down and the work does not cease.
- Donald will write the letter, and Lynne will have the Kennebec County Sheriff's Office serve the letter.

• A motion was made that the Town is all set with their electric and does not want to opt in on the Maine PowerOptions program - seconded. (3-0)

## **OFFICE RENOVATIONS:**
